C. OPEN PUBLIC HEARING

Public Hearing was opened at 6:35PM.

1. PRESIDENT STATES THE PURPOSE OF THE HEARING:

1. 1st Public Hearing for a Paving Project for: Maplewood Meadows Subdivision

2. DPW PRESENTATION

Mr. Abbey stated we set out for these projects during budget time when the council came up with guidelines on how to proceed with getting some of these neighborhood streets fixed and upgraded. This is the first petition that has come through. There are a couple others in the works right now. The necessary petition signatures were validated and approved to move forward. Mr. Wingblad is here tonight from our Engineering Department if there are any technical questions.

3. PRESIDENT ANNOUNCES:

THIS IS THE TIME FIXED FOR HEARING AND CONSIDERING ANY OBJECTIONS AND/OR FAVORABLE COMMENTS TO THE ASPHALT MILL AND RESURFACE, INCLUDING ASSOCIATED STORM SEWER IMPROVEMENTS IN THE FOLLOWING STREETS, TO-WIT:

ALL STREETS LOCATED WITHIN THE MAPLEWOOD MEADOWS SUBDIVISION

4. AUDIENCE PARTICIPATION/PUBLIC COMMENTS

Council listens to objections and/or favorable comments to said improvements.

Geraldine Ruddock of 5460 Aspen Circle in Burton stated she is one of the original homeowners in this area. She has lived here for 19 years. She is in support of this project.

Barry Catrell of 5476 Aspen Circle in Burton stated this is a great deal and it will take the neighborhood 30 years forward.

D. CLOSE PUBLIC HEARING

Public Hearing closed at 6:46PM.

E. COUNCIL DISCUSSION

Mr. Smith asked the administration to describe this process to the public.

Mr. Abbey stated under the Special Assessment Program, someone initiates a special assessment petition. The DPW prepares preliminary cost estimates, petitions are circulated requiring 50% plus one signatures in that district. The district is defined and in this case it is all of Maplewood Meadows subdivision which is roughly 365 parcels. They have done this. We verify the signatures through the Assessor's Office. We set the Public Hearing and hold the Public Hearing. We move forward through council action.

Mr. Fenner stated there is a cost estimate on the petition when it is circulated so no one is shocked. If they have signed it, they understand the approximate cost, correct?

Mr. Abbey stated the preliminary cost estimate is put together with the engineering firms. The petition they signed was at 100% until the council takes action. They were told about the program and how it works. The cost estimate is as accurate as it can be until we go out for bid. This is why the timing is so critical. We get our best bids early in the spring. The timing on this one is perfect. If the bids came in something astronomical, we would have to revisit this. Historically, this does not happen. We are usually pretty accurate.

Mr. Martinbianco stated astronomically doesn't define a number. My understanding is that anything 10% or above would have to be re-circulated or re-certified by the petitioners.

Mr. Abbey stated that is correct.

Mr. Martinbianco asked to hear from Pete Wingblad.

Mr. Wingblad stated there is a 10% contingency and provided further clarification.

Mr. Heffner stated he would like to adjourn the meeting because no action can be taken at a Public Hearing. He recommended adding the action item on this agenda to the City Council Meeting.

Ms. Boggs stated this is a Special Meeting with a Public Hearing so the council can take action if they so choose.

Mr. Heffner asked if that is how the meeting was advertised.

Attorney Doyle stated that is my understanding. As long as it is advertised and published as a Special Meeting, you can take action. I believe it was.
