SPECIAL COUNCIL MEETING MINUTES
APRIL 17, 2001, 6:30 P.M., COUNCIL CHAMBERS

The Special Meeting was called to order by Bob Centilli, Council President, at 6:30 P.M.

PURPOSE OF THE MEETING: PUBLIC HEARING FOR THE PROPOSED BUDGET FOR THE FISCAL YEAR 2001-2002.

PRESENTATION:

Mr. Becker said there is no formal presentation tonight. The Mayor had one previous budget town hall meeting on February 19, 2001. Tonight is the formal public input and there will be a Truth and Taxation Meeting held in June. Also, there will be four or five budget workshop sessions held in the near future.

AUDIENCE PARTICIPATION:

Pauline Dargel 6119 Hugh St., asked about the status of Mark Udell being a police officer as well as a computer tech.

She addressed the issue of having the Senior Center located on Center Road near the senior housing complex. She said the developers could come up with some sort of location and provide some revenue for a building. Mrs. Dargel said after the February session, she contacted the County spoke with Flint Nesmith regarding the use of the community development funds being used for a community center at the existing senior citizens building. She commented that there is a need for more of an outreach for our youth. She also spoke concerning the funds for Conference and Workshop in the Mayor, Council and Fire Department budgets.

Linda Burris-Croley, 6223 Crabtree Lane, asked to have the Council Minutes published in the newspaper.
