BOARD DISCUSSION:

Mr. Bertram inquired regarding zoning and storage inside the building.

Mr. Strasser stated the zoning is R-O, restricted office. It is not uncommon to have storage in the building.

Mr. Bertram asked about a future addition.

Mr. Good said if we continue to grow at the rate we are now, the existing building would turn into 100% office space and they would have more inside storage.

Mr. Bertram questioned disposal of old roofing materials.

Mr. Good said he recycles everything on Dort Hwy. They recycle asphalt products.

Mr. Centilli asked Mr. Good if he has large pieces of equipment.

Mr. Good replied that he has a couple of three quarter ton trucks, and hydraulic trailers to haul scrap.

Mr. Good addressed briefly his current site on Stanley Road.

Mr. Bertram inquired concerning signage, what would be allowed, and the elevation of the property.

Mr. Good said he would like to have a sign that mimics his current dog logo.

Mr. Strasser said he could have 91 square feet of signage out front.

Mr. Strasser addressed the elevation. He offered to have our DPW crew take any fill dirt there if needed. We need some fill sites. It is a pretty steep grade when you come off of the road and he will have to build that up a little bit.

Mr. Good expressed that Davison Surveying is working on those elevations.

Mr. Centilli asked about the building set back.

Mr. Strasser indicated it is 101 feet.

Mr. Bertram commented on the Consumers easement.
